- 2. a. Treasurer Report- Right now between PayPal and Credit Union there is \$3,641.87 in the accounts. Expenses for 2020 are estimated to be \$2,200 which does not include website. More detail to follow in next meeting.
 - b. Jeff has not had time to go to Credit Union and update signature cards. Chuck will go to bank to find out what is needed to get this done.
- 3. Website- Kim spoke with Allison about website maintenance. She is willing to help for a price of \$500 (HALF initial payment, HALF when complete). She will need about 4 weeks to do the necessary fixes. After the initial fix Allison will maintain the website for \$30/hr billed monthly. She usually will respond within a week. Kim will be meeting with Allison and Mark Penburn next week go over the website update. This is a key action since we need the website to conduct the election and to obtain membership approval of the Amended CSO Bylaws. The goal is to have this up and running by the end of November. Backup plan would be to have members vote via email.
 - Chuck spoke with James about keeping the website updated once it is up and running. He said he would need to talk with Allison first to find out if that is possible.
- 3. Elections- Jon will be sending out an email to solicit interest in Board positions; i.e., President, Secretary, and one Member at Large (to replace Mark Lobb). Chuck spoke with James about his status as a Board Member and he is ok with another year on the board as a Member at Large. He also said he would take on the Ride Leader responsibilities
- 5. CSO Bylaws- Amended changes to the Bylaws have been agreed upon. Mike will be sending out a copy of the Proposed changes to the membership for vote on the website once it is up and running.
